## General Regulation of Operation on Vila Real de Santo António Sports Centre

### Article 1.º

#### Object

This Regulation defines the conditions and principles of use, management and disposal of sports facilities of the municipal Vila Real de Santo António Sports Centre, hereinafter referred to as CD as well as their operating rules and access, to be observed by users, individual or collective.

### Article 2.º

#### Property and Management

The CD is owned by the Council of Vila Real de Santo António, under the management of VRSA Urban Management Society E.M. S.A., hereinafter referred as SGU.

### Article 3.º

#### Regulation

1 - In addition to the general provisions of this Regulation, the sports areas mentioned in paragraph 1 of Article 4º, are regulated by specific regulations with operating rules.

2 - The specific regulations referred to in the previous paragraph are subject to approval and modification by the Board of Directors of SGU.

## Article 4.º

### Sport Facilities

1 – The sports facilities on CD are separate in four areas:

a) Stadium area:

- a. Grassfield 1;
- b. Athletics Track;
- c. Indoor Athletics Track;
- d. Gymnasium 1;
- e. Gymnasium 2;
- f. Grassfield 2;
- g. Grassfield 3;
- h. Throwing area;
- i. Synthetic grassfield.

b) Swimming pools area:

- a. 50m Swimming pool;
- b. 25m Swimming pool;
- c. 20m Swimming pool;
- d. Sauna;
- e. Whirlpool.

c) Indoor Sports Hall area:

- a. Ilídio Setúbal Indoor Sports Hall;
- b. Outdoor Multi-sports 1;
- c. Outdoor Multi-sports 2;
- d. Outdoor Multi-sports 3.

d) Tennis and Padel center area:

- a. Red clay tennis courts (5 courts);
- b. Padel courts (4 courts);
- c. Tennis courts of synthetic floor (4 courts + 1 court for balls hitting).

2 – The areas a), b) and c), they all have receptions open for users that work individually, according to the operating hours of the respective areas.

3 – Equally considerate for object of this Regulation, is the physical evaluation office.

## Article 5.º

### Operation

1 - The opening hours of each area will be defined in the respective specific regulation.

2 - In individual cases and subject to the assumption of justified the respective use, the SGU can allow the changing of the opening and closure hours of the sports facilities that make up the CD areas.

3 - Sport facilities can close during periods of time when the frequency of use don't justifies operation.

4 - SGU reserves the right to discontinue the operation of sports facilities as it deems convenient or necessary for failures/operational reasons, execution cleaning, current or extraordinary maintenance, conducting sports events or other events.

5 - Some CD areas can close on certain dates, such as Christmas, New Year, Carnival and Easter, by resolution of the Board of Directors CD.

## Article 6.º

### Users types

- 1 - The CD sports facilities can be attended and used by individual or collective sports.
- 2 - Users of CD sports facilities are grouped into four broad groups:
  - a) High performance users;
  - b) Competition users;
  - c) Leisure users;
  - d) Corporate.

## Article 7.º

### Agreements

- 1 - The SGU may conclude agreements for concessions of sports facilities and CD services.
- 2 - The agreements are analyzed and celebrated case by case basis and approved by the Board of Directors of SGU.

## Article 8.º

### General conditions to access equipments

- 1 - Access to CD's sports facilities, where it is required depending on its nature, is only allowed users equipped for the practice in question and in accordance with the safety requirements or regulations that may be in force in respect of sports facilities to be used.
- 2 - The dressing rooms are reserved for the exclusive use of the users of the respective sports facility.
- 3 - Users of CD may conduct themselves in way not to disrupt services or other users using sports facilities.

4 - The CD reserves the right to deny access or stay in the sports facilities, in particular in the following cases:

- a) For failure to comply with this general regulation or specific regulations of use of the area concerned, and disobedience of staff indications;
- b) Refusal to pay the price associated with the use of the sports facility;
- c) When the users present an improper behavior towards other users or CD service staff;
- d) The animals except in the legally established situations;
- e) When users are presented while intoxicated or under the influence of psychotropic substances or other susceptible state to cause disorder or danger.

## Article 9.º

### Responsibilities

1 - The CD is not responsible for damages or losses caused to users, in the CD space, for actions of third parties.

2 - The CD is not responsible for damage, loss or theft of material goods of users that occur inside the CD.

3 - Users and the entities are liable for any losses or damage to equipment and CD's sports facilities, including all the existing environmental material in green space frame, recreation and leisure.

## Article 10.º

### Price list

1 - By using the CD facilities is made the expected price in the current price list.

2 - The price list is approved by the General Assembly of the SGU.

3 - The price set out in paragraph 1 does not release users and the entities that use the CD of the responsibilities set out in the previous article.

## Article 11.º

### Sports Insurance

1 - The payment of the price of using CD sports facilities guarantees the existence of sports insurance, in accordance with the provisions of paragraph 2 of Decree-Law No 10/2009 of 12 January, as amended, except when users are necessarily covered by specific insurance under the legislation in force.

2 – According to the preceding article, users should ensure up and, if requested, declare that do not have any indications against sports training.

3 - In case of transfer of sports facilities to another entity, the CD reserves the right to require the respective entity submitting the insurance policy that includes the activity in question.

## Article 12.º

### Statement of Responsibility

The CD reserves the right to require users to sign a liability waiver which shall ensure the following:

- a) Have knowledge of regulation rules for the use of the CD;
- b) Not have any indications against the sports training concerned.

## Article 13.º

### Complaint Book

In strict compliance with current legislation, the CD makes available to its users a book of complaints.

## Article 14.º

### Changes

Taking into account changes in the demand for CD's sports facilities, as well as constant improvement of the quality of services provided to users, the SGU reserves the right to revise this Regulation and the specific regulations mentioned in Article 3º.

## Article 15.º

### Omissions

The resolution of omissions or concerns with the implementation of this regulation is of the responsibility of the Board of Directors of SGU on proposals from the CD responsible.

## Article 16.º

### Approval and Implementation

This Regulation will be adopted in the General Assembly of SGU on December 22th of 2014, as part of the CD Business Plan with implementation on the first working day after its approval.
